COMPETITION RULES



Competition spaces are limited to the first 50 applicants who complete the online registration process by the deadline date of May 15th. YUMMIE Competition judging hours are from 12:00 noon to 2:00 p.m.

YOU ARE NOT OFFICIALLY REGISTERED UNTIL YOU HAVE AGREED TO THESE RULES AND SUBMITTED THE ONLINE FORM

1. The YUMMIE Culinary Competition will take place on Sunday, June 3, 2018, during the Casa Pacifica Angels Wine, Food & Brew Festival. There will be 2 judging categories—SAVORY and SWEET.
2. All judging will take place in the official YUMMIES pavilion.
3. Competitors must be set up and have 4 samples ready for a YUMMIES volunteer to pick up at 11:45 am for the first round of judging. Any competitors who do not comply will be disqualified.
4. If you are chosen as a semi-finalist, 12 additional samples will be required.
5. The food submitted for judging must be identical to the samples offered to Festival guests, although presentation may be adjusted for judging.
6. Food will be judged by the following criteria: Flavor (45 points), Presentation (25 points), Innovation (15 points) and Quality of Product (15 points) for a total of 100 points.
7. Awards will be given for 1st, 2nd, and 3rd place in SAVORY and SWEET categories. All winners will receive an award, special recognition, two VIP tickets and preferred booth placement at next year's Festival. 1st Place winners in both categories will also receive an amazing prize package.
8. Festival management reserves all rights to make final decisions regarding any rules or proceedings throughout the course of the Festival and the YUMMIE competition.

Be sure to 'click' the YUMMIE box when you register and also agree to the YUMMIE Competition rules. Registration for the YUMMIES IS NOT COMPLETE without agreeing to the rules. No Exceptions.
